The goods and services shown below are those we can provide to our customers. You may choose only the items you desire. However, any funeral arrangements you select will include a charge for our basic services and overhead. If legal or other requirements mean you must buy any items you did not specifically ask for, we will explain the reason in writing on the statement we provide describing the funeral goods and services you selected.

Professional Services

Basic Services of Funeral Director and Staff\$595

Our basic services charge includes but is not limited to 24-hour availability of funeral director and/or staff to respond to initial request for services, arrangement conference with family or responsible party, arrangement of service, tribute or memorialization. Staff to advise, assist and recommend appropriate personalization and individualization of the services to commemorate the unique life of your loved one. Obtaining and recording vital statistics and biographical information. Death certificate preparation, filing and obtaining necessary permits, authorizations, consents and assignments. Coordination with other parties such as hospital, doctor's office and staff, cemetery, crematory, clergy, and others involved in the services and disposition. Sheltering and care of decedent. Also included in this charge are overhead expenses relative to our facilities such as professional licensing, administrative services, insurance, maintenance, building, and utility expenses, taxes, legal and accounting fees, recording keeping, equipment and inventory expenses.

This fee for our basic services and overhead will be added to the total cost of the funeral arrangements you select. (This fee is already included in our charges for direct cremations, immediate burials, and forwarding or receiving remains). This charge is also included in the other packaged funeral offerings as allowed by law.

Embalming\$395

Except in certain special cases, embalming is not required by law. Embalming may be necessary, however, if you select certain funeral arrangements, such as a funeral with viewing. If you do not want embalming, you usually have the right to choose an arrangement that does not require you to pay for it, such as direct cremation or immediate burial.

- Refrigeration of un-embalmed remains for up to 72 hours \$180
(*\$75. per day thereafter*) *It is the policy of our company, in compliance with State Law to require refrigeration of an un-embalmed body after 24 hours.*

Staff Services, Facilities and Equipment (Monday through Friday)

A. Use of Facilities and Staff for Viewing/Visitation (*per day maximum 4 hours*)..... \$250

Our services include visitation setup, display of floral arrangements, supervision and attendance during the visitation. Additional time may be scheduled at \$75. per hour or portion thereof.

B. Identification Viewing Only (*per 20 minute ID*)..... \$ 75

Our services include a viewing of the un-embalmed deceased through a glass window for up to a maximum 10 people for a maximum of 20 minutes during normal working hours.

C. Use of Staff and Equipment for Funeral, Graveside or Memorial Service \$475

Our services include coordinating the funeral arrangement, supervision of funeral, staff coordination of the funeral ceremony, setup and use necessary equipment for the funeral ceremony.

Forwarding Remains to Another Funeral Home

\$895

This charge includes the transfer of the decedent to our funeral home, basic services of staff, embalming, necessary authorizations, and local transportation to local receiving funeral home or airport. This charge does not include the use of staff and facilities for visitation, rites and ceremonies, or any other service or merchandise not specifically listed.

Receiving Remains from Another Funeral Home

\$895

This charge includes temporary shelter of remains, basic services of staff, and transportation of decedent to local cemetery or crematory. This charge does not include the use of staff and facilities for visitation, rites and ceremonies, or any other service or merchandise not specifically listed.

Immediate Burial (*unspecified day and time*)

from \$1,245 to \$8,490

This charge includes local transfer of deceased to our funeral home, basic services of staff, local transportation to the cemetery, and necessary preparation of permits and authorizations. This charge does not include cemetery or government fees, the use of staff and facilities for visitation, rites and ceremonies, or any other service or merchandise not specifically listed.

Direct Cremation

from \$945 to \$1,390

This charge includes the local transfer of the decedent to our funeral home, basic services of staff, local transportation to crematory, refrigeration (*up to 72 hrs*), preparation of necessary permits, local crematory fee and authorizations. This charge does not include government fees, the use of staff and facilities for visitation, rites and ceremonies, or any other service or merchandise not specifically listed.

If you would like to arrange a direct cremation you may use an alternative container. Alternative containers encase the body and may be made of materials like fiberboard or composition materials (with or without an outside covering). The containers we provide at are made of cardboard or fiberboard.
